Presenters responded to questions regarding decision-making authority, impact of Community Choice Aggregation programs on customers, recouping of costs, renewable energy options, low-income customer assistance, customers on SCE green rate. 
1. Ayn Craciun expressed support for joining a Community Choice Energy program.

Council consensus was for the City Manager to coordinate questions and answers prior to scheduling the matter for future discussion and consideration. No further action was taken.


ADJOURNMENT: Mayor Ackley adjourned the meeting at 7:05 p.m. to the August 18, 2021 Regular City Council Meeting.
