3.2 REVIEW OF EXISTING NON-RESIDENTIAL ADDRESSES

ACTION:

- 1) Implement a policy to require addresses to be included as appropriate on new, replacement, or reimaged monument signs at existing sites. The recently adopted monument sign addressing provisions included in the Security Code as described in the staff report to allow this requirement to be imposed with the new work.
- 2) Promote voluntary improvements through landscape management (typically pruning trees or shrubs) where deemed effective.
- 3) When properties are being renovated or reimaged, promote voluntary improvements through the use of addressing on monument signs where landscape management solutions are not effective and through the use of onsite wayfinding signage.
- 4) When cases are brought to the attention of the Department of Community Development where a building site is accessed from a street other than the one to which it is addressed, work with the property owner on a voluntary basis to provide a combination of directional and monument signage if it does not currently exist.

CHALLENGING CITY DECISIONS

The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitations period is specified by any other provision. Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred.

If a person wishes to challenge the nature of the above actions in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Irvine, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.
