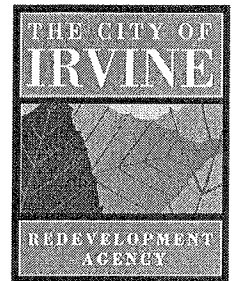

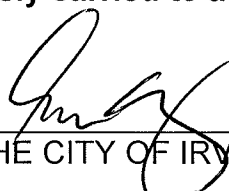
City Attorney Phil Kohn, on behalf of the City Council and Redevelopment Agency, announced that no reportable action was taken in Closed Session on Item No. 1.

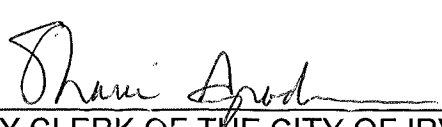

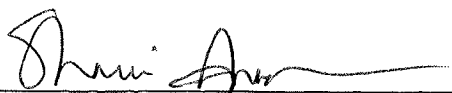
