1.7 COOPERATIVE AGREEMENT WITH ORANGE COUNTY TRANSPORTATION AUTHORITY FOR THE "GO LOCAL PROGRAM"

ACTION:

- 1) Authorized the City Manager to sign, on behalf of the City, Cooperative Agreement No. C-6-0723 for the "Go Local Program" with the Orange County Transportation Authority and any subsequent amendments thereto. **(Contract No. 5440)**
- 2) Approved a budget adjustment to appropriate \$100,000 of new Measure M revenue for contract services support of the "Go Local Program" efforts.

1.8 RENEW LICENSE AGREEMENT NO. 2206 WITH SOUTHERN CALIFORNIA EDISON COMPANY FOR PARK, PUBLIC RECREATION, AND LANDSCAPE PURPOSES, WALNUT VILLAGE (PLANNING AREA 10)

ACTION: Authorized the Mayor to execute License Agreement Number 2206, between the City of Irvine and Southern California Edison Company. **(Contract No. 5443)**

1.9 MAP, BOND, AND AGREEMENT, FOR TRACT MAP NO. 16989, IRVINE BUSINESS COMPLEX (PLANNING AREA 36)

ACTION:

- 1) Approved Tract Map No. 16989 (Central Park).
- 2) Authorized the Mayor to execute the agreement and accept the security from Lennar Homes of California, Inc., a California Corporation, guaranteeing survey monumentation for Tract Map No. 16989 by November 30, 2008.

ACTION: Adopted **ORDINANCE NO.07-01** - AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF IRVINE, CALIFORNIA DETERMINE AND DECLARE PRIMA FACIE SPEED LIMITS ON VARIOUS STREETS WITHIN THE CITY OF IRVINE, AND OFFICIALLY ESTABLISH THESE DECLARATIONS THROUGH AN AMENDMENT TO THE "CITY OF IRVINE ENGINEERING AND TRAFFIC SURVEYS FOR SPEED LIMITS," AS MAINTAINED BY THE CITY TRAFFIC ENGINEER AS THE OFFICIAL DOCUMENTATION OF DECLARED PRIMA FACIE SPEED LIMITS
