

**VILLAGE OF VERNON HILLS
ORDINANCE 2023-024**

AN ORDINANCE AUTHORIZING APPROVAL TO EXPEND FUNDS FROM THE DUI AND STATE SEIZURE FUNDS FOR THE PURCHASE AND CONTRACTING WITH FLOCK SAFETY FOR ONE LAW ENFORCEMENT GRADE PORTABLE LICENSE PLATE RECOGNITION CAMERA FOR A TOTAL TWO-YEAR EXPENDITURE NOT TO EXCEED \$8,500

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills maintains a State Seizure Fund, from which funds are used for the purposes of funding activities and equipment related to the enforcement of criminal laws; and

WHEREAS, the Village of Vernon Hills maintains a Driving Under the Influence (DUI) Fund, from which funds are used for the purposes of funding activities and equipment related to enforcement of alcohol-related laws; and

WHEREAS, the need for this equipment was unforeseen and therefore not included in the current FY22-23 budget; and

WHEREAS, staff recommends entering the new agreement with Flock Safety for one Falcon Flex portable license plate recognition camera, for a total expenditure of \$8,500 over 2 years, with the 2023 payment not to exceed \$4,250; and

WHEREAS, a payment from DUI Fund Account #1709109 540050 in the amount of \$750, and a payment from State Seizure Fund Account #5803030 540050 in the amount of \$3,500 is requested for the procurement of one Flock Safety Falcon Flex portable license plate recognition camera; and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT:

The Village Manager is hereby authorized to execute all required documents to purchase the Falcon Flex portable camera and contract with Flock Safety for an amount not to exceed \$8,500.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:

The Finance Director is hereby authorized to release \$3,500 from State Seizure Fund Account # 5803030 540050 and \$750 from DUI Fund Account #1709109 540050 for fiscal year FY-23.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2023-024.
