Hi Ponha,

It looks like we'll have a work order issued Monday for the cameras to come down, and then it should be a matter of a few days at most for the work to commence. Two quick notes I just discussed with Josh:

1. One item on our checklist is confirming whether Flock owes KCHA anything for the partially executed Phase II contract. We've already recognized that revenue on our side, and the preference internally is to avoid processing a return. I've attached the contract for reference.
2. We're also hosting a brief webinar next Wednesday addressing recent reports and media coverage about Flock, along with updates to our data-sharing policies and new privacy safeguards. The session will reaffirm that customers maintain full ownership and control of their data and highlight the steps we're taking to strengthen transparency and community trust.


