Good Morning Kameron,

Happy Tuesday. We engaged with the city on permitting for the one location that fell in their ROW (camera F018 on your [Deployment Plan](#)). Based on the update I received from our Permitting team, the city does not allow LPR cameras in their ROW. Which meant we had to find a private property location that kept the same intended capture. We also had to slightly adjust the placement of F014 as it was encroaching on city ROW. The camera now falls on KCHA property per our maps.

I brought up the private property permissions in my last reach out. All cameras fall in KCHA property. I assume we have your permission to move forward with scheduling these or do we need to wait?

Hope you're well. Outside of the one location we show as being in city ROW, F018 on your [Deployment Plan](#), all other locations are coming back as falling private property (PP). In order to install at these location we need our PP Permission form completed and signed by the property owner. Please find it attached. They can also simply share an email with us stating they approve of the install.

We will get started on the city permitting. Do you happen to know any of these property owners? If not we can do some digging to find out who the property is registered to. Usually getting the permission to install means more coming from locals as opposed to some guy from a company the owner has probably never heard of.
