Thanks again for getting back to me. A couple of notes based on feedback from the deployment engineer, Jeremy:

[WA- King County Housing Authority Phase II](#)

1. For the parking lot light pole at Mardi Gras - can you confirm that it is owned by KCHA and that it has constant AC power available.
2. For the Cascade locations, the team would like to use the light posts there. I let them know that you didn't know who owned them, so our permitting team is going to reach out to the city. Any issues with that?
3. For the Seaola Gardens #2 location, Jeremy did the calcs and it seems there may not be enough solar due to trees/shading. Could we use this pole? We may need to ask the local government there as well.
