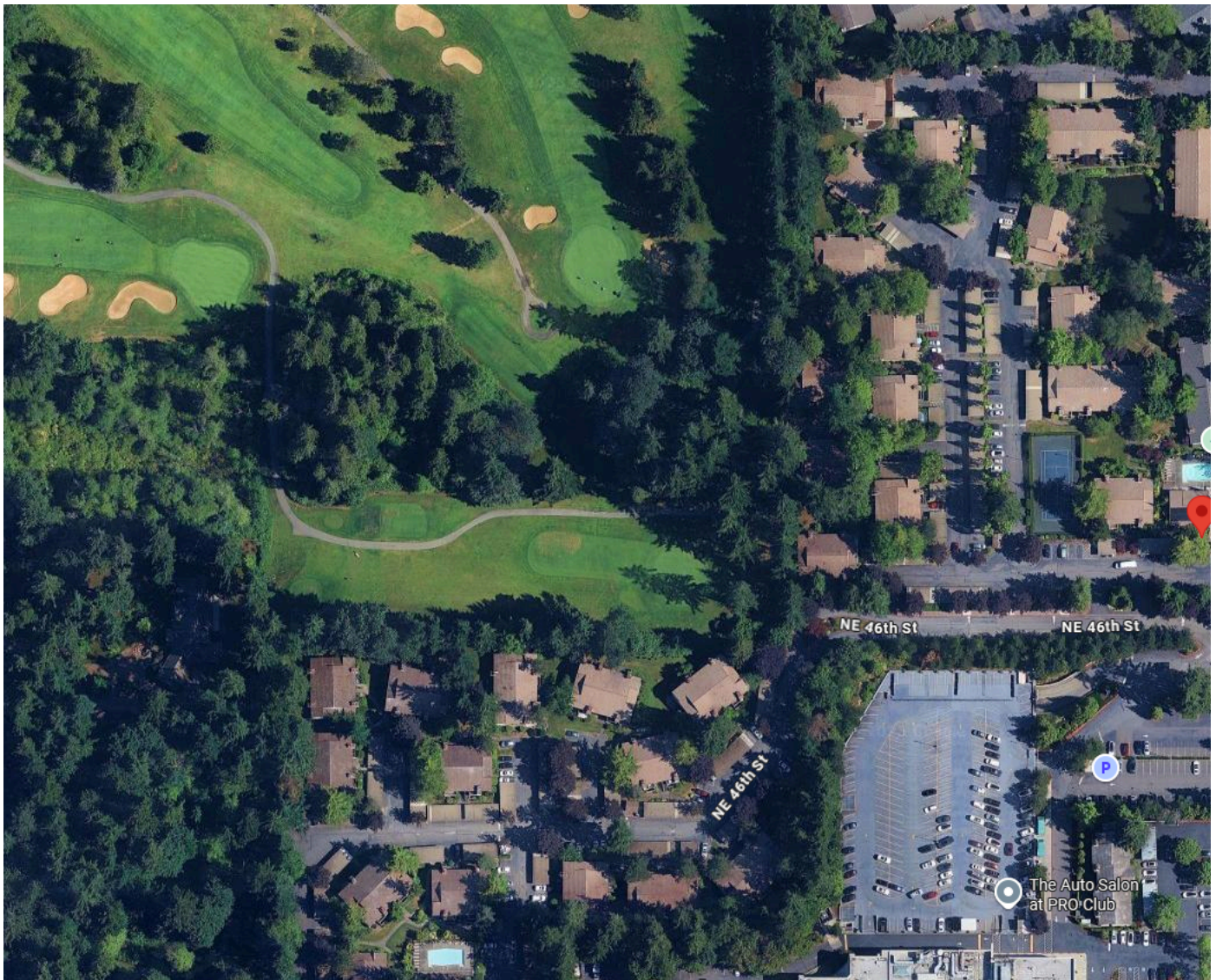
We are looking to get a proposal for another property of ours.

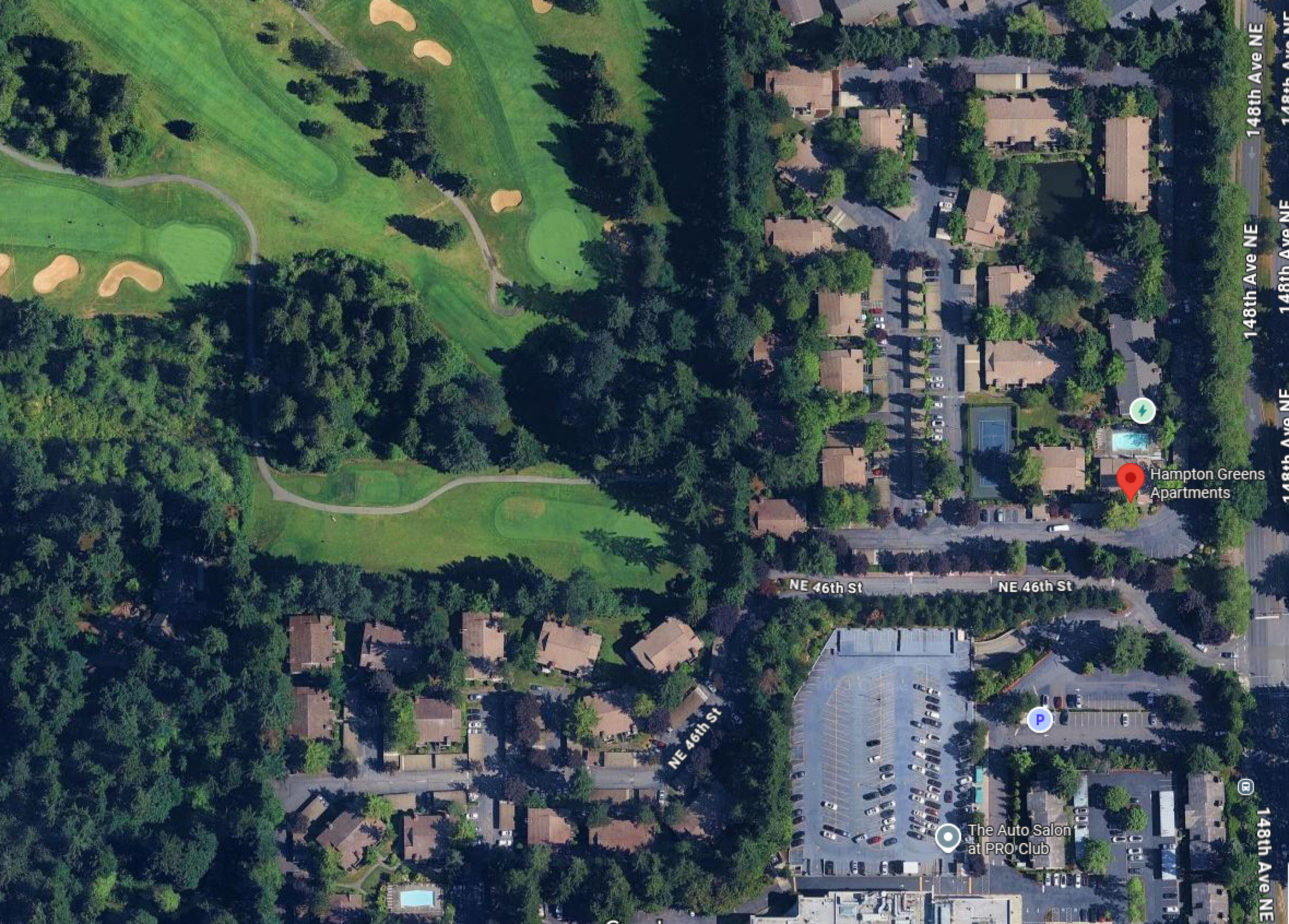
