ALL SIDEWALK SHALL HAVE A SEPARATE ADA INSPECTION PRIOR TO ACCEPTANCE. Applicant shall contact Miss Utility prior to commencement of work.
Applicant is responsible to perform all soil testing and analysis prior to commencement of work, as required to ensure proper foundation design and construction for proposed pole.
Applicant is solely responsible for ensuring traffic control devices are set up in accordance with Delaware MUTCD (Delaware Manual on Uniform Traffic Control Devices).

Applicant shall coordinate with DelDOT Inspector and DelDOT Safety Officer prior to commencement of work, to coordinate lane closure requirements.
